Remember, if you complete your screening at your doctor's office, you must bring the Provider Notification Form with you and have your doctor complete it. Already completed your screening as part of your annual physical this year, but forgot to bring the Provider Notification Form with you to your appointment? No problem! Just print out the form and ask your doctor's office to complete it using the results from the date of your annual physical exam.
